Based on a long series of will abstracts that appeared over a period of 45 years in The New England Historical and Genealogical Register, this work encompasses what amounts to the first 30 years or so of the Suffolk County, Massachusetts, estate records (1640-1670). Altogether, the series refers to some 12,000 persons with regard to family relationships.

The earliest records in Lunenburg County cover this entire area. The records included in this volume have been abstracted from wills and administrations found in the back of Deed Book I and Will Book I & II. Because some of the early records of Lunenburg County do not seem to have been preserved, the compilers have included in this volume some 20 pages of records abstracted from ORDER BOOK 1-6. These notes from the order books give names of deceased persons not of record in the will books, and names of orphans and other notes pertaining to the period covered in Volumes 1 and 2 of these reprints. Also found is a listing of marriages taken from Deed Books and other vital records, as well as apprenticeships, guardianship and much other valuable data important to the person searching this area of Virginia. There are more than 2,200 names of persons found in the above records listed in the full-name index. These records are from the late 18th through the early 19th century. Over 6,000 individuals are named in the marriage records. The probate records identify heirs, with relationships, and give the probate date.

"Bath County, in western Virginia, was formed from Augusta, Botetourt, and Greenbrier counties in 1791. It is itself the parent county for part of Alleghany County, Virginia, and Pocahontas County, West Virginia. This work consists of genealogical abstracts of the oldest surviving wills and inventories for Bath County--but that's not all. Interspersed with the inheritance records are abstracts of bonds, powers of attorney, estate settlements, articles of agreement, and other records of genealogical import. In general the will abstracts furnish the name of the testator, his county of residence, the names of witnesses and executors, the date of probate, and the names and relationships to the testator of the heirs to the will. All told, nearly 15,000 early residents of Bath County appear in these pages" -- publisher website (August 2007). This invaluable compilation includes abstracts of early wills, deeds and marriages from courthouses, and records of old Bibles, churches, graveyards, and cemeteries from the following Kentucky counties: Anderson, Bourbon, Boyle, Clark, Estill, Fayette, Garrard, Harrison, Jessamine, Lincoln, Madison, Mercer, Montgomery, Nicholas, and Woodford. An extensive surname index contains about 3,750 entries.

A Virginia native, Taylor became a Methodist preacher and missionary in California. This volume provides an important narrative account of Taylor's career as an itinerant revivalist and popular author, in which he toured the eastern United States, the British Isles, and Australasia. Taylor's participation in the South African revival made him an evangelical celebrity. The author also follows Taylor's important visits to India and South America, where he initiated new Methodist missions in those contexts and pioneered the concept of "tentmaking" missions. In 1884, Taylor was elected missionary bishop of Africa by his church. By the end of his life, Taylor had recruited or inspired hundreds of Methodists to become foreign missionaries.
