Recent studies provide evidence that companies that were sold by private equity investors achieved an annual growth in value of 24% to 29% - comparable listed companies managed added value of only nine percent. Private equity

Voice is gaining importance as private equity investors increasingly focus on strategic and operational value creation in addition to or instead of leverage effects.
